PG Rec. Hockey League: Individual Participant Agreement: Code Of Conduct:

The Prince George Recreation Hockey League establishes the rules and protocols then monitors and enforces the application of those rules and protocols using a governing body in the form of an elected "Executive" group. To the rules and guidelines listed below the "Executive" may at any time change or update these rules and protocols.

By selecting "I agree" you are confirming you have <u>read this document</u> and understand and accept the authority of the P.G. Rec. Hockey Executive Governing body in all aspects of application of league rules, including but not limited to suspensions and fines for violations.

• A Player may not participate if they are experiencing any covid 19 or flu like symptoms.

<u>Individual and Team requirements, rules and expectations:</u>

A player may not play in the P.G. Rec. Hockey League under any circumstances until they have completed the following tasks and protocols:

Online Player registration requirement:

(Registration Fines and suspensions here are an Amendment to league manual Part one June 2021)

Every person that participates in the P.G. Rec. Hockey League must register online.

If a player participates without first registering online their team will be fined \$100 per incident and the player will be suspended 2 games, no exceptions no excuses.

• Players Should Register online with their team a minimum of 12 hours before they start to participate in the PG Rec. Hockey League: We would permit a player to register <u>before they enter the arena</u> and up to 15 minutes before game time, but the timekeeper would not have that information.

Waiver Requirement:

• Players at point of registration must go online review the **Prince George Recreation Hockey League Event Participation Waiver** that is supplied by the league read and select "I AGREE" before they can complete their registration and participate in the PG Rec. Hockey League.

Section One: Governing Play:

- All CAHA rules are in effect unless otherwise stated.
- PG Rec Hockey League Handbook rules in effect with exceptions listed above and below. (League Manual part one June 2021 available on the home page under league notices)
- The rules section (part two) of the League manual are being updated, for now we have posted the rules section of league manual (revised Feb 2016) for reference if you have any questions contact league admin.
- The League discipline committee has final authority concerning all rules and regulations including, but not limited to, suspensions, expulsions, and general discretion of conduct. By selecting "I Agree" you acknowledge and accept this authority

Protecting officials:

- There will be zero tolerance for abuse of officials.
- Players that complain continually about calls to the officials could be suspended even if the complaints do not constitute serious abuse. If you think you can do better, we need more officials!
- You can not play unless there are officials at the rink to referee your game always keep that in mind.

Section two: Individual Code Of Conduct

- Maintain and enhance the dignity and self-esteem of other individuals by demonstrating respect for fellow athletes regardless of body type, athletic ability, gender, ethnic or racial origin, age, religion, disability, sexual orientation, or economic status.
- Any behavior that constitutes harassment i.e., comments or conduct directed toward an individual or group, which is offensive, abusive, racist, sexist, degrading or malicious will not be tolerated by the league members and management and will result in suspensions and possible expulsion from the league.
- • Any behavior that constitutes sexual harassment such as unwelcome sexual comments, advances or conduct of a sexual nature will not be tolerated by the league members and management will result in suspensions and possible expulsion from the league.
